FEBRUARY MEETING —

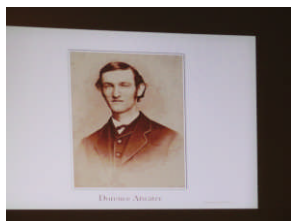

FEBRUARY PROGRAM: "Indiana at Andersonville." Mr. John Urschel is an accomplished historian with degrees in history from Wright State University and extensive work as an archivist and records manager.

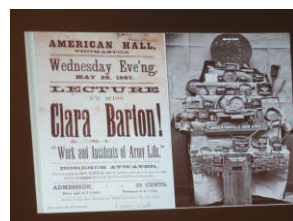


The Andersonville prison was located in Georgia and opened in February 1864. It was designed for 10,000 men but eventually it held 33,000 men. Approximately 13,000 men died while the prison existed. The prison held 2,025 Hoosiers from 130 units and 716 are buried at the Andersonville Cemetery. Indiana troops became POWs at battles such as Brices Crossroads, Tennessee and Atlanta Campaigns, Chickamauga and Wilderness. Mr. Urschel's program emphasized the Andersonville National Cemetery as it relates to the Hoosiers buried there. Mr. Urschel's book, *Indiana at Andersonville*, is a compendium of Indiana's soldiers held captive at that prison and survived. The book also contains photos of the Hoosier tombstones and information related to that soldier.

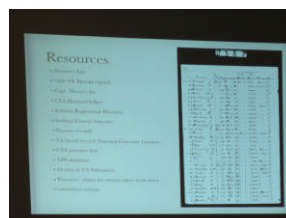
Dorence Atwater (1), while a Union prisoner, compiled a death register for the camp. In the summer of 1865, Atwater, along with Clara Barton (2), returned to Andersonville to find, identify, and properly bury the soldiers. Building upon Atwater's register Mr. Urschel consulted several research sources (3) to identify these soldiers. Often in the research Mr. Urschel found errors in the records that led to mistaken identities. While visiting Evansville, Mr. Urschel was able to research an Evansville survivor — William A. McFarland. (4)



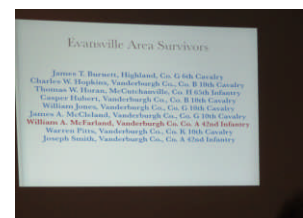

JOURNALS, DIARIES and LETTERS, ETC.:

Confederate Chaplain Father James B. Sheeran of the 14th Louisiana Regiment records the following event which occurred in the Army of Northern Virginia on March 23, 1864.



“This morning the snow is 18 inches deep. I feel very much stiffened after my cold ride last evening. This was an exciting day about camp. Two of our divisions, Johnson’s and Rodes’, fought a regular scientific battle with snow balls. There were some 8,000 men engaged and the lines were so regularly formed, the movements so systematic, the officers displaying so much activity at the head of their commands, their men fighting so stubbornly, now advancing on their opposing column, now giving way before superior numbers that one would forget for a moment that it was merely a sham. At one time we would see a body of troops marching through an adjacent woods endeavoring to flank their enemy; soon a counter movement would be made. Now a charge and a yell and many prisoners captured. For nearly two hours this battle of snow balls lasted. Now commences a most amusing scene. Johnson’s whole division commences a rapid retreat but with solid and unbroken lines. Rodes’ division following them in utmost disorder and almost exhausted with laughter. Now the order is given, “Halt! Change front! Charge!” Now commences one of the most amusing and laughable scenes. Rodes’ division is routed and driven for over half a mile and even through their own camp. Our boys came home as proud as if they had gained a victory over the Yankees.”

NOTICE: Dan Hartman, longtime member of the Southern Indiana Civil War Roundtable, passed away on February 29, 2016.

March 17th’s program will feature Mark Laubacher presenting on “Cold Blooded Envenomation of 1861-65”. Over the past 125 years, the literature authored by those who did not participate in the Civil War has continued to perpetuate the error that snake bites to the soldiers did not occur. Individuals, still today, generate theories to justify their belief of such erroneous statements. But from May 1861 through April 1865, *Medical and Surgical History of the War of the Rebellion* documents 178 snake bites with two being fatal on the Union side. One would expect similar snake bite numbers on the Confederate side. Unfortunately, during the Richmond fires of 1865, the Confederate Surgeon-General records were lost.

Letters to home, post war memoirs, and diaries from soldiers of both Union and Confederate sides detail not only snake bite, but envenomation. This presentation will examine seven snake bite cases on the Union side, three of which are clearly not captured in the Federal statistics with one being fatal. He will also review six snake bites on the Confederate side.
